THE CUSTOMER ADVISED THEY DID NOT WANT TO GO BACK IN WITH THE ORIGINAL TRANSMISSION. PRICED THE EATON 13 SPEED TRANSMISSION REPLACEMENT TO THEM AND ADVISED THERE WOULD BE UNKNOWN EXTRA LABOR AND PARTS INVOLVED. THEY APPROVED THE REPAIRS(3862)-ONCE TRANSMISSION ARRIVED IT WAS ASSEMBLED AND ATTEMPTED TO INSTALL ONTO THE ENGINE. FOUND THE FORK SHAFT WAS RUNNING INTO THE MOTOR MOUNTS AND WOULD NOT CLEAR. REPLACE THE GEAR HOUSING

WHILE THE VEHICLE WAS GETTING THE TRANSMISSION REPLACE, THE CUSTOMER ASKED TO REPLACE THE GEAR HOUSING WITH THE UPDATED HOUSING(3862)-DRAINED OIL. DISCONNECTED BATTERIES. DRAINED COOLANT. REMOVED OIL LEVEL SENSOR, FILLER NECK, DIPSTICK, AND PAN BOLTS, REMOVED PAN AND OIL FILTERS. SUPPORTED THE ENGINE FOR THE REMOVAL OF THE GEAR HOUSING, REMOVED ALL ACCESSORIES ON BOTH SIDES OF THE ENGINE. REMOVED ALL ELECTRICAL CONNECTIONS AND COOLANT LINES ON THE GEAR HOUSING. REMOVED THE VALVE COVER PLACED ENGINE AT TDC AND LOOSENED ENGINE MOUNTS. UPON REMOVING THE VALVE COVER A BOLT HAD BROKEN ON IT. A NUT WAS WELDED TO THE REMAINDER OF THE BOLT AND AFTER 3 ATTEMPTS IT WAS REMOVED. REMOVED ALL BOLTS HOLDING THE BELL HOUSING TO THE REAR GEAR COVER. ONCE OFF THE GEARS WERE MARKED AND REMOVED. REMOVED THE REAR TIMING PLATE AND INSTALLED THE NEW ONE, ONLY INSTALLED 3 BOLTS, PERFORMED TIMING PROCEDURE ON BOTH THE CAMSHAFT AND CRANK SHAFT GEARS ACCORDING TO IMPACT. ALSO COMPLETED THE INSTALL ON THE REAR PLATE FOLLOWING IMPACTS TORQUE SEQUENCE AND SPEC. INSTALLED ALL THE GEARS AND TIGHTENED TO SPEC. INSTALLED THE UPDATED GEAR HOUSING. BOLTED DOWN TO THE ENGINE MOUNTS. INSTALLED ALL BOLTS HOLDING THE GEAR HOUSING TO THE PLATE AND GEAR HOUSING TO THE BLOCK. INSTALLED THE REAR MAIN SEAL FOLLOWING IMPACT PROCEDURES AND TOOL LIST. INSTALLED THE FLYWHEEL AND NEW PILOT BEARING, ONCE THE HOUSING WAS ON THE ACCESSORIES WERE PUT BACK ON, INSTALLED OIL PAN NEW OIL FILTERS, FILLED WITH OIL, INSTALLED THE UPPER COVER FOLLOWING IMPACT PROCEDURES AND TOOL LIST. INSTALLED THE VAVLE COVER AND BOLTED DOWN. RAN AIR COMPRESSOR INLET OVER VALVE COVER, INSTALLED THE CRANKCASE BREATHER TUBE TO THE SIDE OF THE VALVE COVER, RAN THE ERG CROSSOVER TUBE AND BOLTED DOWN. CONNECTED THE AIR FILTER BRACKET TO THE TRUCK AND SECURED THE AIR FILTER TO THE TRUCK. STARTED THE TRUCK. TRUCK STARTED UP WELL. DURING A TEST DRIVE, FOUND THE TRUCK HAD A BOOST LEAK. FOUND THE CHARGE AIR BOOTS LEAKING ON THE PASENGER SIDE OF THE ENGINE. CUT OFF OLD CLAMPS HOLDING CHARGE AIR COOLER BOOTS AND INSTALLED NEW BOOTS AND CLAMPS. RETESTED. ALL WORKING PROEPRLY.
