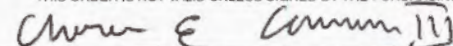

DESCRIPTION OF WORK**Building Sewer**

First job scope- 150' sewer replacement with additional cleanouts.

After initial job completed plumber ran camera and found additional stoppages due to collapsing pipe and multiple bellies. Original sewer line is cast iron that has been reworked with Nuflow type system, both of which have failed due to age. Below job scope is recommendation to remediate the same problems in the future.

2nd additional job scope to complete replacement of sewer line. Replace 600' of sewer line, set in select back fill and compact under road areas where heavy equipment and vehicles travel. We will ensure all fall is shot in and drainage is up to code. We will install cleanouts every 100' to ensure any future stoppages can be reached and cleared due to the nature and length of sewer line.

We will run Building Sewer on a 1.0 percent grade or $\frac{1}{4}$ " per foot fall towards tap. We will install the sewer in accordance with the International Plumbing Code and we will tie it into the city tap or septic system with clean out at the location of tie in. We exclude haul off of additional dirt due to select backfill being utilized. We will spread out to original grade once all backfill has been made. We will plug off the system at the tap and test the system before backfilling to ensure quality and safety regardless of geographical location or directions of municipalities. We will backfill and grade trenches back to natural grade but we exclude any seeding, sodding or replacement of vegetation.

If any unforeseen issues arise that cause job scope to deviate outside of this initial proposal, customer will be notified immediately. Once discussed with customer and additional work is approved, work will commence.
